As per AICTE, Prevention and prohibition of Ragging in technical Institutions, Universities including Deemed to be Universities imparting technical education.F.No.37-3/Legal/AICTE/2009, Dated 01-07-2009:

- A) It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
- B) It shall be the duty of the Anti-Ragging Squad to be called upon to make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.
